

The Division of Disability Resources and Educational Services (DRES) is the designated office of the University of Illinois at Urbana-Champaign that maintains disability-related documents, certifies eligibility for disability services, determines reasonable accommodations, and develops and coordinates plans for the provision of such accommodations for students with disabilities.

Academic services for students with disabilities are coordinated by DRES personnel who serve as access specialists. Each student who registers with DRES for the purpose of requesting disability-related academic adjustments and accommodations will be assigned an access specialist based upon the student's primary disability. Additionally, there are services offered by DRES that are commonly used by all students with disabilities.
